

**TERMS AND CONDITIONS FOR  
ALLIANZ ROAD TO REWARDS PROMOTION  
(for policyholder)  
(the “Promotion”)**

1. Allianz Insurance Singapore Pte. Ltd. (“Allianz”) is offering a 10% discount off premiums (the “Discount”) and UNIQQIFT Vouchers worth \$100 (the “Vouchers”) to applicants who have successfully purchased an Allianz Motor Protect Policy or an Allianz Electric Motor Protect Policy (“Qualifying Policy”) during the promotion period, from 1<sup>st</sup> August 2024 to 30<sup>th</sup> September 2024 (both dates inclusive) (“Promotion Period”) and meet the requirements below.
2. The Vouchers are limited to the first 5,000 Allianz Motor Protect Policies and Allianz Electric Motor Protect Policies issued during the Promotion Period. For the avoidance of doubt, the gifting of Vouchers shall end when the first 5,000 Allianz Motor Protect Policies and Allianz Electric Motor Protect Policies have been issued, or on 30<sup>th</sup> September 2024, whichever occurs first.
3. For intermediated channels, Policies have to be transacted on the AZConnect platform in order to be valid for this Promotion.
4. By participating in this Promotion, the applicant hereby agrees to be bound by these Promotion terms.

**Discount Promotion**

5. If an applicant purchases a Qualifying Policy during the Promotion Period on the Allianz website or through the Allianz intermediary portal AZConnect using the relevant promo code (the “Promo Code”), the applicant will be entitled to the following discount (the “Discount”) upon successful issuance of the Qualifying Policy.

Qualifying Policy	Discount	Promo Code

6. Only the main policyholder will be entitled to the Discount. Application for the Qualifying Policy and full insurance premium payment for the Policy must be received and accepted by Allianz during the Promotion Period for the applicant to be entitled to the Discount.

**Voucher Promotion**

7. To qualify for a Voucher:
  - i. New sign-ups for a Qualifying Policy must be submitted on Allianz website or through the Allianz intermediary portal AZConnect during the Promotion Period.
  - ii. Full premium payment must be successfully received by Allianz during the Promotion Period.

- iii. Premium payment must be made by way of yearly mode.
  - iv. As part of the application for the Qualifying Policy, the Policyholder must provide:
    - a. their email address,
    - b. mobile number, and
    - c. consent to be contacted for marketing purposes via email .
  - v. The Qualifying Policy must be within the first 5,000 Allianz Motor Protect Policies and Allianz Electric Motor Protect Policies issued by Allianz during the Promotion Period.
8. Policyholders or insured persons who cancel any existing Allianz Motor Protect Policy or Allianz Electric Motor Protect Policy to purchase a new Allianz Motor Protect Policy or Allianz Electric Motor Protect Policy respectively during the Promotion Period shall not receive a Voucher for such purchase
9. There is no limit to the number of sets of Vouchers that each applicant can receive, provided that each purchase of Qualifying Policy meets the requirements in these Promotion terms.
10. The Vouchers are given on the condition that the Qualifying Policies issued must not be terminated, cancelled, or voided for any reason whatsoever within 6 months from the policy issuance dates. Otherwise, the applicant will have to reimburse Allianz the full amount and value of the Vouchers.
11. Redemption details for the Vouchers will be emailed to the successful applicants within 60 days from the date of the policy issuance at their email addresses or mobile number registered with Allianz at the time they apply for the policies, provided that such applicants have provided and not withdrawn consent to be contacted for marketing purposes via email. Allianz shall not be liable for late, lost, misdirected, or unsuccessful efforts to contact and notify the successful applicants.
12. The Vouchers including any unused value cannot be exchanged for cash, kind, or other denominations and are subject to the terms and conditions of the issuing merchant.
13. Allianz reserves the right to (i) replace the Vouchers with items of similar value ("**Replacement Item**") at any time without prior notice, and (ii) substitute any applicant who is found to be ineligible, disqualified or not eligible to participate in this Promotion with a different applicant.
14. Allianz may use third-party vendors for Vouchers redemption. The Policyholders' relevant personal data will be shared with such third-party vendors and their subcontractors (if any), for this purpose.
15. Allianz is not the manufacturer or merchant of the Vouchers or any Replacement Item and provides no warranty in respect of it. Allianz is not an agent of the third-party vendors providing the Vouchers. Allianz shall not be responsible for all warranties, expressed or implied, including implied warranties of merchantability, and fitness for a particular purpose and against infringement of intellectual property rights in respect of the Vouchers or any Replacement Item. The Vouchers may be subject to additional terms and conditions, and you agree to comply with such terms and conditions as made applicable by the third-party vendors. Any disputes regarding the Vouchers or any Replacement Item shall be resolved directly with the third-party vendor.
16. No joint venture, sponsorship, tie-up, agency, or any other relationship is intended or created between Allianz and the manufacturer or merchant of the Vouchers or any Replacement Item, or any

other party or its products. Neither is this promotion intended or deemed to be a connection with or use of the brand name of the Vouchers or any Replacement Item, or any other party or its products.

17. Allianz shall not be responsible or liable for:

(a) any losses, damages or otherwise suffered by any person if it is unable to perform its obligations under the terms and conditions of this Promotion, due directly or indirectly to the failure any machine or communication or computer system, industrial dispute, war, Act of God, or anything outside the control of Allianz;

(b) any notice or communication, direct mailer, or email which gets lost, misplaced, defaced, tampered with, stolen, damaged or misdirected or which the applicant does not receive;

(c) any breakdown or malfunction in any computer system or equipment; or

(d) any liabilities, losses and damages, claims, costs and expenses or for any special or consequential damages or losses in connection with, related to or resulting from the use of the Vouchers or the Replacement Item (if any).

#### **General (Applicable to both Discount Promotion and Voucher Promotion)**

18. This Promotion is applicable to new applications only during the Promotion Period and will not be valid with other promotions, discounts, offers, vouchers, rebates, or privileges unless otherwise stated. For clarity, this Promotion does not apply to renewals of existing Qualifying Policies.

19. By participating in this Promotion, the applicant agree and consent that Allianz and its related corporations may collect, use and/or disclose the applicant's personal data for the purposes as may be reasonably required to administer this Promotion.

20. The Discount and Vouchers are not exchangeable for cash or any benefit in kind.

21. This Promotion does not affect or change any term of the policy contracts for the Qualifying Policies. If there is any inconsistency between any term of this promotion and any term of the policy contracts for the Qualifying Policies, the term of the policy contracts shall prevail.

22. Allianz reserves the right to change the terms and conditions of this Promotion without any prior notice to the customer.

23. This promotion is not valid in conjunction with any other promotion or discount, unless otherwise stated in writing by Allianz.

24. Allianz's decision on all matters relating to this Promotion (including the issuance of the Vouchers and/or the Replacement Item(s)) shall be final, conclusive and binding. No appeal will be entertained.

25. The terms and conditions of the Promotion shall be governed by and interpreted in accordance with Singapore law. The courts of Singapore shall have exclusive jurisdiction over any disputes arising from the terms and conditions, including the validity and enforceability thereof.

26. The Eligible Policies are protected under the Policy Owners' Protection Scheme which is administered by the Singapore Deposit Insurance Corporation ("**SDIC**"). Coverage for your Policy is automatic and no further action is required from you. For more information on the types of benefits that are covered
